Bluehost Scholarship Program Official Rules

1. Eligibility

- a. The Bluehost Scholarship Program (the "Scholarship Program") is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are eighteen (18) years or older at the time of entry. - b. The judging period will be from April 2, 2017 at 12:00 a.m. Mountain Time ("MT") through April 30, 2017 at 11:59 p.m. MT (the "Judging Period").
- c. Winner declaration will take place on or about May 1, 2017.
- d. The scholarship winners will be contacted via email or phone on or about May 1, 2017.

4. The Scholarship Program

- a. In order to enter the Scholarship Program, a student must complete and submit his/her one-page essay via scholarship@bluehost.com, along with his/her first and last name, phone number, address, college/university attending, expected year of graduation, and intended major or area of study.
- b. Three individual students will be selected to receive a \$1,500 scholarship based on their winning essays in response to the following questions: "How has the internet changed the traditional collegiate system and are those changes good or bad? How do you believe the web will revolutionize post-secondary education in the future?" (the "Scholarship Questions")

5. Judging:

 - iii. Thought leadership

- **6. Scholarship Notification** On or about May 1, 2017 through May 5, 2017 (the "Notification Period"), the Sponsor will attempt to notify Scholarship winners via the

email or telephone number provided in the original entry submission.

7. SPONSOR'S DECISIONS AS TO THE ADMINISTRATION AND OPERATION OF THE SCHOLARSHIP PROGRAM AND THE SELECTION OF POTENTIAL SCHOLARSHIP PROGRAM WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SCHOLARSHIP PROGRAM.

8. Verification of Potential Scholarship Winners
